## Goulburn flow monitoring



The 2019–20 Goulburn Monitoring Evaluation and Research Annual Report has been released.

Some highlights include:

- Confirmation of the links between flows and bank condition, deposition of sediments and seeds and the presence and condition of bank vegetation. Understanding these relationships helps with planning deliveries of water for the environment and improved management of irrigation flows in summer to limit damage to the riverbanks and vegetation.
- A significant finding of the 2019–20 surveys was the collection of nationally threatened trout cod. Trout cod had not been collected during surveys for three years but were collected again in 2020. Spawning of trout cod was also detected in November 2019 surveys and has now been detected in each of the past three (2017 to 2019) spawning seasons. Other species collected were Murray cod, silver perch and Murray River rainbowfish.

The report also makes recommendations for future management of river flows to protect and improve the health of the lower Goulburn River including delivering at least one spring environmental flow every year.


